**Section 6: Accidental Release Measures**

**PERSONAL PRECAUTIONS:**

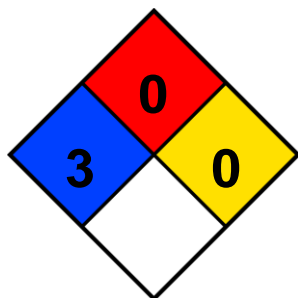
